The Ontario Soil and Crop Improvement Association (OSCIA) is excited to offer funding to support the Merit-based adoption of the application of biological nitrification inhibitor inoculants onto field crops. This funding opportunity has been approved with the aim of improving understanding of how biological inoculant products impact greenhouse gas (GHG) emissions, soil carbon sequestration, and crop yields. As part of the project OSCIA staff will also work alongside you to understand the wider agronomic impacts of the practice on your system and the barriers you face while implementing the practice.
